Your neighbourhood officers have arrested 3 people in connection with the criminal damage at Starbucks on Blackburn Road on 13/06. They have been released on bail for further enquiries.

Following multiple reports of shoplifting around the Brightmet area, the neighbourhood team have arrested 3 people, responsible for hundreds of pounds worth of thefts over the last couple of months. This has resulted in 29 charges between them.

Off - Road Bikes

We have had numerous complaints of off-road motorbikes in the past few months.

We want to make you aware privately owned e-scooters remain illegal in the UK. The only e-scooters permitted are the rented versions seen in city centres. E-scooters should not be ridden on the roads or pavements. They are classed as a mechanically propelled vehicle. When used on a road the use then changes the status to motor vehicle, and as such there is then a requirement for licence and insurance. E-scooters can be seized under Section 165A Road Traffic Act 1988. They are difficult to retrieve from a recovery agent once seized as they cannot be insured.

E-bikes are legal as long as they do not have a motor exceeding 250W and have not been adapted in any way. To remain legal an e-bike offers pedal assistance to 15.5mph, after this the electric motor stops providing the assistance. E-bikes become illegal if the motor is more powerful than 250W, or the bike can move with pedalling - for example, a twist and go throttle, or the motor provides assistance beyond 15.5mph. This then put the bike into the mechanically propelled vehicle bracket, and again if used on a road it is then classed as a motor vehicle.

The other type of electric bike we see is the Suron type off-road bike. These are essentially an electric off-road bike and are not permitted on UK roads - unless registered and insured, and the rider has a licence to ride that category of machine. The Suron bikes are particularly dangerous due to the speed they can achieve and are often ridden by inexperienced riders with no helmet or protective clothing. We are seeing more and more collisions involving Suron bikes on our roads. If a Suron bike is used on the roads it can be seized under Sec 165A RTA and are difficult to retrieve from recovery agents due to inability to insure them.

Operation Hurricane (GMP's response to this problem) is now underway, and we will be ploughing additional resources into problem locations over the summer months. If you have any information about bikes / riders causing anti-social behaviour, please pass this onto your local officers or anonymously via Crimestoppers. Ensure your home is secure whilst on holiday

Going on holiday is an exciting time and something that we all look forward to. However, before going away on holiday you need to think about the security of your home, as returning from a holiday to find out your home has been burgled would be both upsetting and stressful.



Most burglars are opportunists, with their motive in the main being to get into a property as quickly as possible, steal something of value and then leave as quickly as possible. A secure home will therefore be a deterrent to them and reduces the chance of you becoming a victim of a burglary.

Follow the advice below from Secured by Design to help keep your home safe while you're away

- Ensure doors and windows are in a good state of repair and that good quality locks or bolts are fitted to all outside doors
- Ensure the locks on all windows and doors are in good working order and are locked. Any broken or defective locks should be repaired by a Locksmith registered with the Master Locksmiths Association www.locksmiths.co.uk
- Remove the keys from all windows and doors and put them in a safe place when you leave the house
- If you have an intruder alarm, make sure it's set. If you don't have one consider having an approved alarm system installed. Visit www.policesecuritysystems.com/choose-an-alarm to find out all the information that you need to know to assist you in choosing the right security system for your home or business
- Make use of timer plugs with lamps and radios to make your house seem occupied. You can also get photosensitive bulbs, which are activated when it gets darker
- Don't leave valuable items such as laptops and jewellery in view of windows. Lock valuable items away in a ground anchored safe or you could consider leaving important documents and valuable items with other family members whilst away
